REGISTRATION REQUIREMENTS AND MODALITY

Admission of applicants is decided through review of their applications by a Selection Committee under the Foundation Director's authority.

Eligible applicants must meet the following requirements:

- **have at least a four-year university degree** (master's degree, LL.M or equivalent)
- **by exceptionally possess any person which have a sound experience in the field of human rights**, gained in governmental entities, intergovernmental or non-governmental organizations or possess similar experience.

After examination of the applications, admitted auditors will be informed by email only. Final registration will only be valid upon receipt of the payment of the registration fees on the Foundation bank account.

REGISTRATION FEES

- Individual cost : **100 euros**
- Individual student special reduce cost (on presentation of proof) : **80 euros**

PAYMENT OF REGISTRATION FEES—NON REFUNDABLE

The payment should be made only by credit card online on the secure site of the Foundation - the bank fees are the responsibility of the participant.

Payment is requested upon notification by email.

No other payment method is accepted. A paid invoice will be sent after payment.

MANDATORY TEST Saturday 24 July 2021

A Certificate of achievement will be delivered to the auditors who have successfully passed **a mandatory online knowledge test** of twenty multiple-choice questions. Certificate of attendance will be given to the auditors who will failed on this test. Link will be communicated to the auditors.

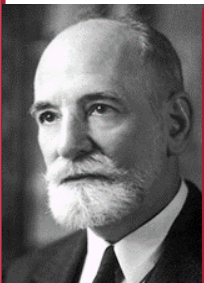
